OUR HISTORY

The College of Emergency Nursing Australasia (CENA) Ltd. was formed through the amalgamation of all six state Emergency Nurses Associations (New South Wales, Queensland, South Australia, Tasmania, Victoria and Western Australia) on the 26 November 2002.

A discussion paper was developed in December 2001 through the six ENA state branches to commence negotiations in order to form a truly national representative body of emergency nurses.

In May 2002 the inaugural meeting was held in Victoria with two executive representatives from each state ENA. At this meeting the foundations of CENA Ltd. were laid, the National Steering Committee was appointed, and a national survey developed and subsequently conducted.

The survey, sent to every state ENA member, demonstrated overwhelming support for a truly national representative body for emergency nursing, that being the College of Emergency Nursing Australasia.

Following this, our National Constitution was developed. Subsequently, the inaugural board of CENA Ltd. comprising two representatives from each of the six states was elected in April 2003.

The main objective of CENA Ltd. is to provide one united national voice for emergency nursing and emergency nurses. We believe that collectively we can do so much more to address the issues facing emergency nursing today.

CENA's foundations lie in a 20 year history of individual state ENAs, and it is through this expertise and experience that we are able to provide a strong voice representing emergency nurses at state, national, and international levels.
