PHILIPPA MOORE PUBLICATION PRIZE
ACKNOWLEDGING EXCELLENCE IN PUBLICATION

CENA recognises the importance of publication to the practice and scholarship of emergency nursing. The *CENA Philippa Moore Publication Prize* is an award of up to \$500 designed to reward and encourage CENA members to publish articles that are relevant to emergency nursing.

Philippa Moore was a highly respected emergency nurse, active member of the Emergency Nurses' Special Interest Group and the Emergency Nurses Association of Victoria, and the College of Emergency Nursing Australasia. Sadly, Philippa died in 2003 after a short illness.

Nomination Guidelines

Nomination forms are available from the CENA website (www.cena.org.au). The following entry criteria apply:

- Nominator(s) must be financial member(s) of CENA;
- Nominee must, at the time of nomination, be a financial member of CENA for a period of at least 2 years;
- Only items published between 1st July 2009 - 30th June 2010 will be considered;
- In-Press items if available on-line prior to 30th June 2010 will also be considered (proof of availability date must be supplied);
- Publications must be directly related to emergency nursing and may include scholarly textbooks, book chapters, and journal articles that are peer-reviewed;
- A copy of the item must be submitted with nomination;
- Finalists (or appointed delegate) must register to attend the 2010 International Conference Dinner.

Nominations must be submitted using the attached nomination form and address all entry criteria. Completed nominations must be received by the due date to:

Nominations received after the closing date or those do not address the entry criteria will be excluded from selection. A selection panel will be appointed and chaired by the Editor-in-Chief of the Australasian Emergency Nursing Journal. The decision of the Editor-in-Chief as chair of the selection panel is final.

The Philippa Moore Publication Prize shall be awarded at the Conference Dinner during the 8th International Conference for Emergency Nursing: '*Global Emergency Nursing Leadership: Shaping Practice and Service*' in Canberra, Australia, 13-16 October, 2010. In the event the nominee is unable to attend the conference dinner, the nominee must nominate a delegate to accept the award on their behalf. Failure of nominees to appoint a delegate will result in forfeiture of any awarded prize. Winner's names will be placed on the honour board on the official CENA website in perpetuity. Names and photos will be published in official CENA and Elsevier publications.
